**Description:** The Environmental Advisory Commission advises the City Council on issues relating to preservation and enhancement of the environment in the City. Recommendations should consider Scottsdale's commitment to a balance of environmental, economic, and social sustainability, including both short-and long-term impacts. Special Qualifications - As specified in the Scottsdale City Code, The membership of the commission shall reflect both scientific and nonscientific interests and shall include representatives with professional backgrounds in environmental and sustainability-related fields, as well as representatives from the business community and community at large.

**Purpose:**

The purpose, powers and duties of the Environmental Quality Advisory Board are combined in S.R.C., Sec. 2-303.

**Powers and Duties:**

S.R.C., Sec. 2-303. - Purpose; powers and duties.

The Scottsdale Environmental Quality Advisory Board will advise the City Council on issues relating to environmental quality and on the prioritization of future environmental activities and programs. The board shall also assist the council by providing nominations for any environmental achievement awards established by the Council. The board may also provide assistance to staff in development contacts that may result in coordinated efforts between the public and private sectors to address environmental concerns.

**Bylaws:**

The Environmental Advisory Commission approved bylaws in March 2001 and revised them on November 17, 2004, January 19, 2011, and January 20, 2021.

**Bylaws Provisions:**

Purpose and activities of the board

ByLawProvision

Organization: make-up of the board, officers, vacancies, resignation to seek public office, committees, legal counsel, proxy voting

Clarification of meeting times, locations and procedures: quorum, member attendance, vacancies, conflict of interest, abstention

Official records: definition, recording of vote, retention of files, public records

Amendments and rules: standing rules, Robert's Rules of Order, interpretation and conflict

**Absences (Bylaws):** If member a is absent from three (3) consecutive, or four (4) of six (6) regular meetings, the member shall be removed from office effective on the date of such Board member's third consecutive or fourth absence out of six (6) regular meetings. Upon the Board member's third consecutive or fourth absence out of six (6) regular meetings and upon a majority vote of the Board, the Board may elect to set aside the termination provision and determine an appropriate time extension for such Board member to return to the next regular, or special, Board meeting. If the Board fails to vote on or votes not to grant a time extension, the affected Board member shall automatically be removed from the Board on the date of such Board member's third consecutive or fourth absence out of six (6) regular meetings.

On May 3, 1993, the Council adopted Ordinance No. 2528, which created the Environmental Quality Advisory Board (EQAB). Initial appointments to the board were made on June 22, 1993.

On July 1, 2019, the Council adopted Ordinance No. 4402 changing the name to Environmental Advisory Commission.
