Description: On November 1, 2011 the Council combined the Housing Board and the Neighborhood Enhancement Commission to form the Neighborhood Advisory Commission (Ordinance No. 3964). The Neighborhood Advisory Commission consists of seven (7) members each of whom shall be appointed by the City Council. The purpose of the Neighborhood Advisory Commission is to advise and make recommendations to the City Council on policies, plans, strategies and programs for the preservation, improvement and revitalization of Scottsdale's housing and neighborhoods. The Commission may advise and make recommendations on other issues and matters as the City Council may direct. The Commission may make recommendations to other City boards and commissions.

Purpose:

The purpose of the Neighborhood Advisory Commission is to advise and make recommendations to the City Council on policies, plans, strategies and programs for the preservation, improvement and revitalization of Scottsdale's housing and neighborhoods. The commission may advise and make recommendations on other issues and matters as the City Council may direct. The commission may make recommendations to other city boards and commissions.

Powers and Duties:

From S.R.C. 2-223 (a) and (b): (a) The purpose of the Neighborhood Advisory Commission is to advise and make recommendations to the city council on policies, plans, strategies and programs for the preservation, improvement and revitalization of Scottsdale's housing and neighborhoods. The commission may advise and make recommendations on other issues and matters as the city council may direct. The commission may make recommendations to other city boards and commissions. (b) In accordance with City Council Resolution Number 8929 approve or disapprove applications made pursuant to the R1-7 Residential Exterior Enhancement Program.
