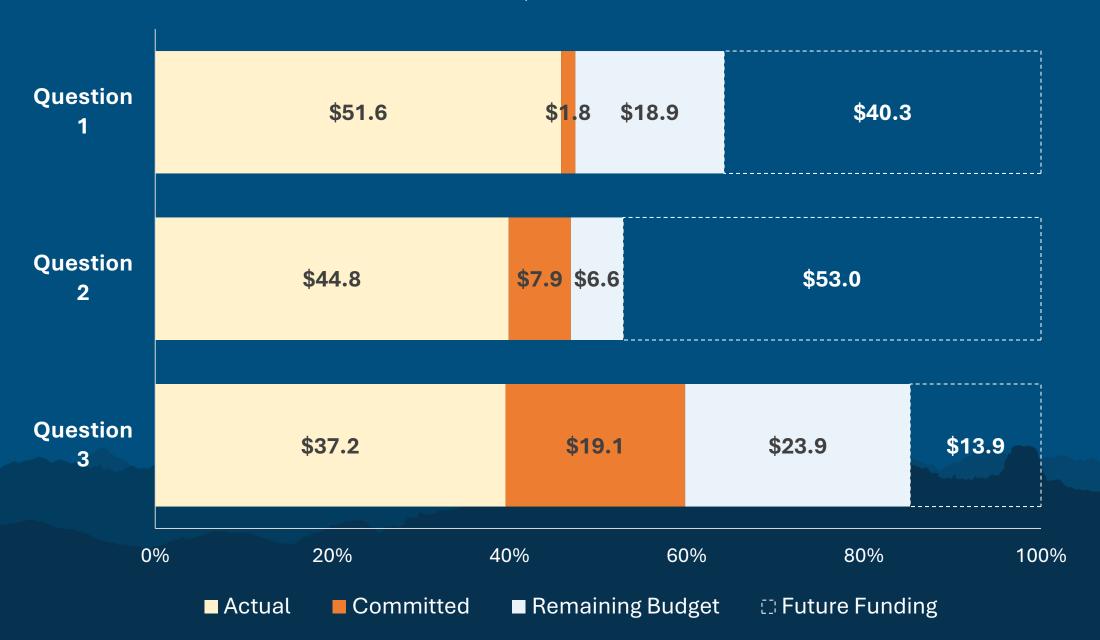

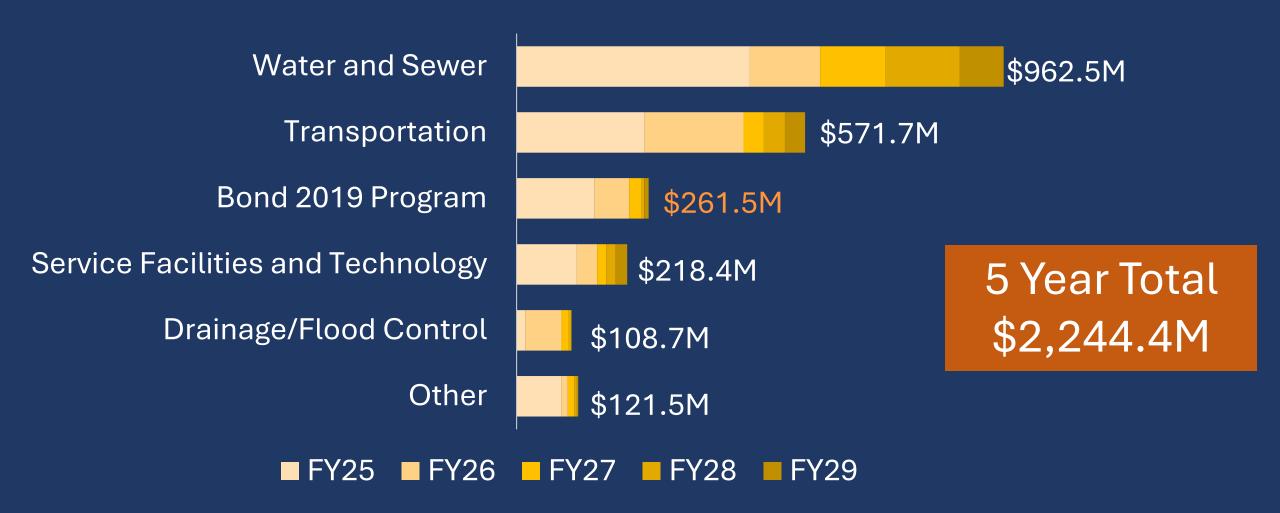
CIP BUDGET DEVELOPMENT PROCESS TIMELINE

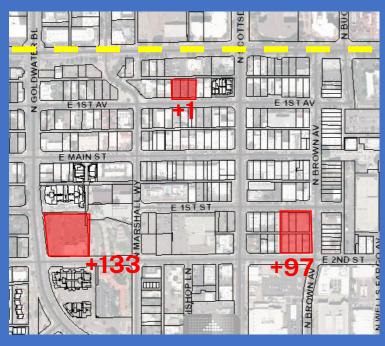
