NCAA Men's Final Four Event

CITY COUNCIL MEETING

NCAA Men's Final Four Event

- The Phoenix Final Four Local Organizing Committee (PLOC) has proposed a one-year agreement with the City of Scottsdale to support the NCAA Men's Final Four Championship basketball tournament.
- The national semifinals will be played on Saturday, April 1, 2017, with the national final on Monday, April 3, 2017.
- 80% of the game attendees will be from out-of-state and will represent fans of the final four teams and corporate sponsors.

Analysis & Assessment

- It is estimated that the tournament will draw 1,500 national media members with an estimated regional economic impact of \$130 million.
- The SCVB has also provided how they will partner with the city and the PLOC to leverage the tournament for the local tourism industry.
- There is a public purpose for the city's expenditure and the marketing and promotional benefits required under the contract provide direct consideration substantially equal to the city's expenditure.
