Background

- In 2011, state legislation placed several requirements on municipalities' development impact fees.
 - Senate Bill 1525 / Arizona Revised Statutes §9-463.05
- City's development fees are adopted for Scottsdale Water's water and wastewater activities.

Background

To comply with new requirements, the City:

- Updated Land Use Assumptions (LUA)
- Updated Infrastructure Improvement Plans (IIP)
 - Water
 - Wastewater
- Updated Development Impact Fees eff. July 1, 2014

Background

ARS §9-463.05(G) further requires the City to either:

(1) Appoint Infrastructure Improvements Advisory Committee (subject to additional statutory requirements).

OR

(2) Provide for a biennial certified audit of its land use assumptions, infrastructure improvements plan and development fees.

Scottsdale Water opted for the biennial certified audit.

This first audit is for July 1, 2014, through June 30, 2016.

Background

The audit shall be conducted by "qualified professionals":

- Not employees or officials of the city.
- Did not prepare the IIP.
- Defined as professional engineer, surveyor, financial analyst or planner providing services within scope of their license, education or experience.

Scottsdale City Auditor issued Request for Proposals, selected Qualified Professional firm, and administered the audit contract.

 Raftelis Financial Consultants, Inc. performed the Biennial Certified Audit.

Background

The City is required to post the report on its website and conduct a public hearing within 60 days.

- Posted for Audit Committee: Sept 13
- Audit Committee voted unanimously to accept the report: Sept 19
- Also posted to Audit Reports webpage: Sept 20
- Public hearing scheduled: Oct 10 (27 days after initial posting)

OBJECTIVE OF THE AUDIT

To review the progress of the City's LUA and IIP, including the collection and expenditures of development fees for identified capital projects in the IIP, and evaluate any inequities in implementing the adopted IIP or imposing the adopted development fees differently from the adopted fee schedules.

RFC'S APPROACH

- Audit period from FY '15 and FY '16
- Review actual growth and LUA
- Evaluate current levels of service and capacity available for growth?
- Review collection/expenditure of fees for each necessary public services
 - Are funds segregated?
 - Are funds used appropriately as defined by SB 1525?

BIENNIAL CERTIFIED AUDIT RESULTS (LUA)

- Progress of IIPs is consistent with LUA
 - Does not result in any inequities in implementing the plans
 - Actual growth is consistent with land use assumptions
 - Recent growth has not put a strain on available water and wastewater capacity
- Progress of IIPs is consistent with LUA

BIENNIAL CERTIFIED AUDIT RESULTS (WATER IIP AND WASTEWATER IIP)

- Both written plans sufficiently address and provide information required by SB 1525
- Available capacity remains consistent with infrastructure planning
- Current levels of service remain consistent with levels defined in IIPs

BIENNIAL CERTIFIED AUDIT RESULTS (WATER IIP AND WASTEWATER IIP)

- Projected demands remain consistent with planning projections
- Progress of IIPs does not result in any inequities in implementing the plans or imposing fees

BIENNIAL CERTIFIED AUDIT RESULTS (COLLECTION AND EXPENDITURE OF FEES)

- Fee collections are consistent with permit information
- Actual expenditures are consistent with project scheduling in IIPs
- Expenditures are consistent with requirements of SB 1525

BIENNIAL CERTIFIED AUDIT RESULTS (COLLECTION AND EXPENDITURE OF FEES)

- Fee funds appropriately accounted for and used for purposes authorized by statutes
- Collections and expenditures of fees does not result in any inequities in implementing the plans or imposing the fees
