Human Services Manager Eugenio Munoz-Villafane: Thank you. Good evening, Mayor Lane. Vice Mayor Phillips, members of the Council. We thank you for the opportunity to speak to you about one of our programs this summer, and, again, my name is Eugenio Munoz-Villafane, and I'm the program manager with VISL community programs. I want to recognize the people who are here. Sue Oh,

and Julia Bautista and Norma Saldana. Without this core team, what we will tell you about this evening would not have happened. Also we have present here in the chambers also the executive director of Scottsdale Community Partners, Jenny Adams and then also two of their board members, Susan Vargas and Rosemary Young-Carlin who following our presentation will receive a recognition of our appreciation for their generous support in this year's program. So with that, Sue?

Human Services Specialist Sue Oh: Good evening, Mayor Lane, Vice Mayor Phillips and members of City Council, my name is Sue Oh. I have a brief update on the success of this year's Covering the Bases Back-To-School Event which took place on July 25<sup>th</sup> at the Scottsdale Stadium. This year once again the program surpassed 1,000 students, 1,025 to be precise. 900 students attended the main event at the stadium, and 125 additional students came throughout the makeup days. Each student received a backpack full of school supplies, a pair of shoes, socks, new underwear and a pair of shorts and a pair of pants and two shirts.

Honor Health's Noah's Team was at the event providing dental screenings and making well check appointments for the students. First Things First provided activity bags for younger siblings who were too young to be in the program. They support early literacy. The Scottsdale public library provided books for all the students who attended the event. The Scottsdale Unified School District provided meals for all the students that were in attendance.

Police officers of Scottsdale association provided services to create kid care I.D.s, and everyone stayed hydrated at the event with the donation of water by Mercy Care. We were supported by 251 volunteers who earnestly logged 1,046 hours assisting with the logistical work done before, during, and right after the event. Also 53 city of Scottsdale employees logged an estimated 1,025 hours during the event.

We would like to especially thank Scottsdale Community Partners board for coordinating volunteers before, during and after the event, and for taking a larger role this year, as the fiscal agency for donations, major purchases, and promotion. We would like to thank Lisa Randall of Family Promise of Greater Phoenix, Cooper Merrill and former commissioner Raul Zubia for coordinating volunteers the day of the event and others for helping us with the background checks of the volunteers and at the day of the event.

Dan Miller and Harry Ericson and the city of Scottsdale special events team and lastly community Services division Bill Murphy and Greg Bestgen for their leadership and support of the program. Successful events are not possible without the support of key sponsors, businesses, civic, faith and tribal organizations. We would like to recognize our major sponsors, city of Scottsdale Community Partners, Scottsdale Unified School District, Police Officers of Scottsdale Association Outreach, Honor Health, neighborhood outreach, access to health, also called Noah, First Things First, Mercy Care, and Talking Stick Resort.

Lastly, I would like to thank everyone we may not have mentioned such as Scottsdale residents, would

Patricia Travis: Good evening. Thank you. My name is Patricia Travis. I live at 7575 East Indian Bend Road in Scottsdale. I would like to thank the Council for all you do for the city. And I would ask you to literally turn on the light. What I mean by that on Indian Bend near the railroad park, by the way thanks for the fabulous concerts this summer. We all enjoyed those. As you turn, as you go east on Indian Bend Road, the very next way you can turn right is Rocking Road. And just past that, the next entrance is an area into four developments, Sienna condominiums, the Corinth, basically Silverado Golf Course and the villas and there's 280 units in Sienna alone. So it's a heavily traveled corner.

When I came and saw this area last year, I noticed that the light that used to shine up on that sign advertising those four communities was out. So on the board there at Sienna, we contacted the city and asked you to come out and get the light working. Well, somebody came out and basically just removed it. Now, I know that cities probably didn't know this or didn't know how important it was to us, but for a lot of us that are mature in that dark area, it's very difficult to know where to turn right to go into that, and it gets a lot of traffic there. I many times myself have turned into Rocking Road and had to turn around and go back and, I turned too early because you couldn't see it. So what we are asking for is if you could help me, just send me the right department of people to contact to basically get a nice light back up on that, on that nice sign there, so we know where to turn safely. That is my request.
