Wonderspaces Elsewhere

- Wonderspaces is an interactive, experiential and immersive artwork show.
- This is the events first request for event development funding.
- The Tourism Development Commission has unanimously recommended that City Council support the event funding agreement.



2

Analysis & Assessment

- The Wonderspace Elsewhere show will run from September to November with an anticipated attendance of over 100,000.
- The festival producer is allocating \$160,000 toward event marketing against a total event budget of \$1.6 million.
- The marketing and promotional benefits outlined in the proposed agreement provide direct consideration substantially equal to the city's expenditure.

Analysis & Assessment

The City of Scottsdale's tourism event program has identified the development of new or existing events as a tourism program priority more specifically the development of events that occur in the tourism shoulder seasons such as the summer months. In addition, the opportunity to develop events that create synergy with an existing event such as Canal Convergence has been identified as an event development objective.

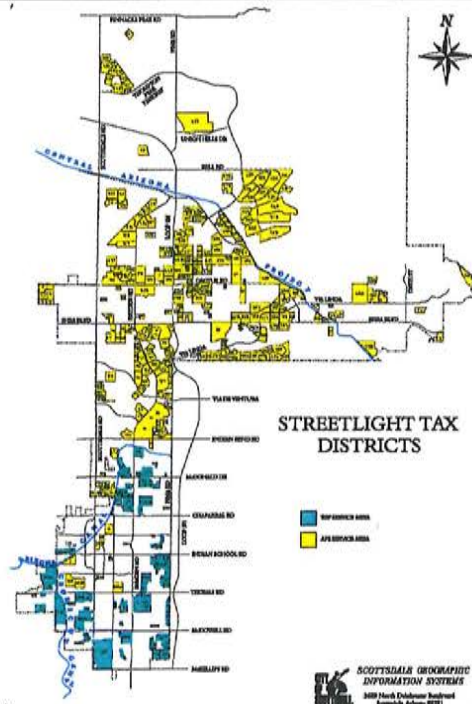

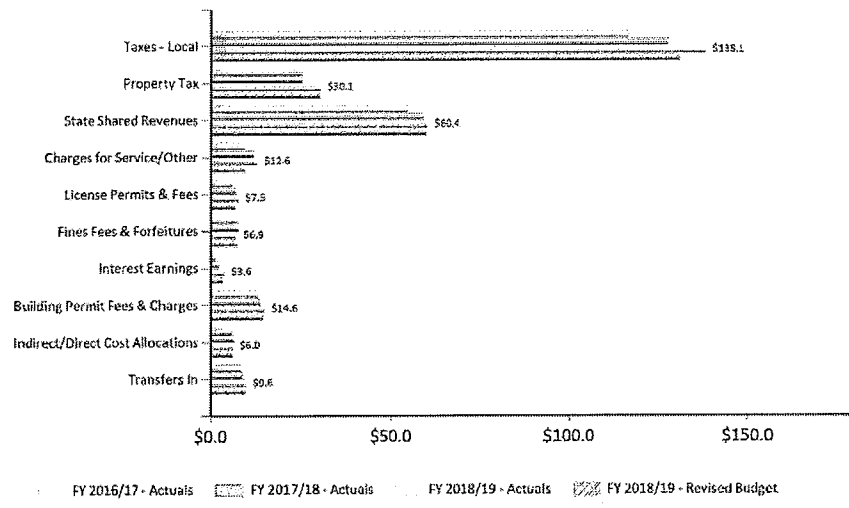

General Fund Operating Sources May 2019: Fiscal Year to Date

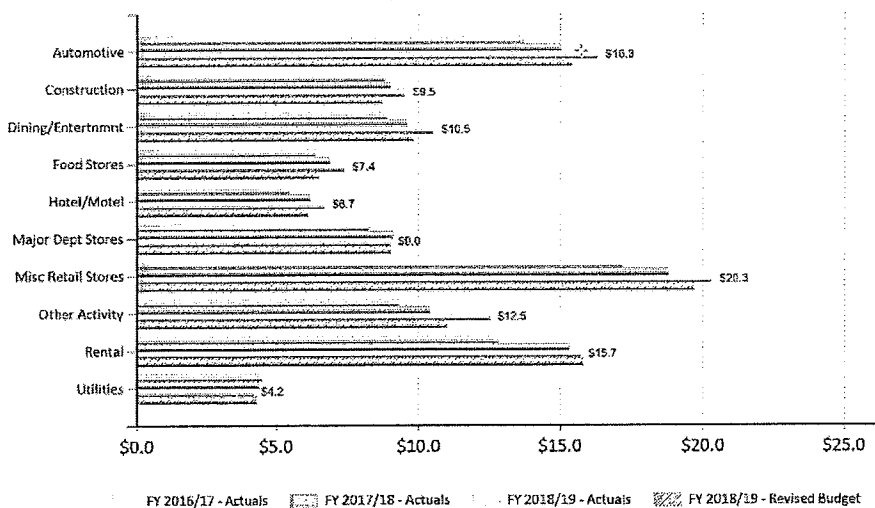

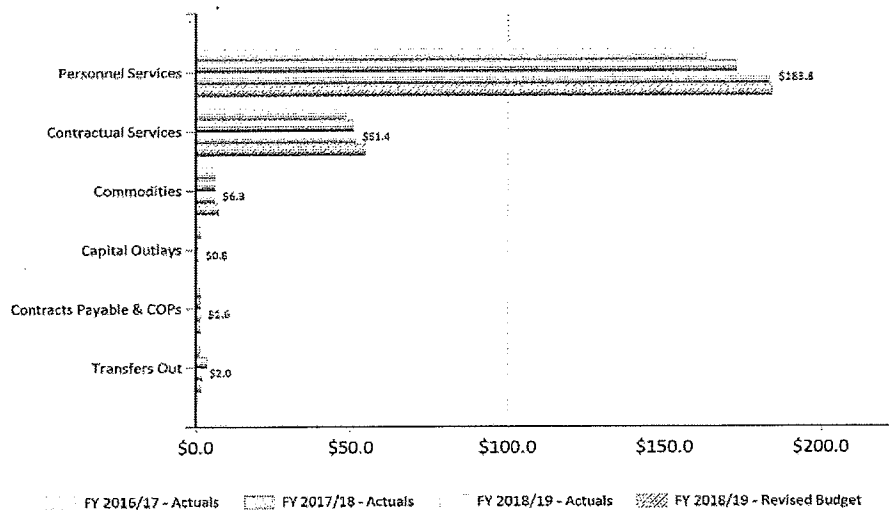

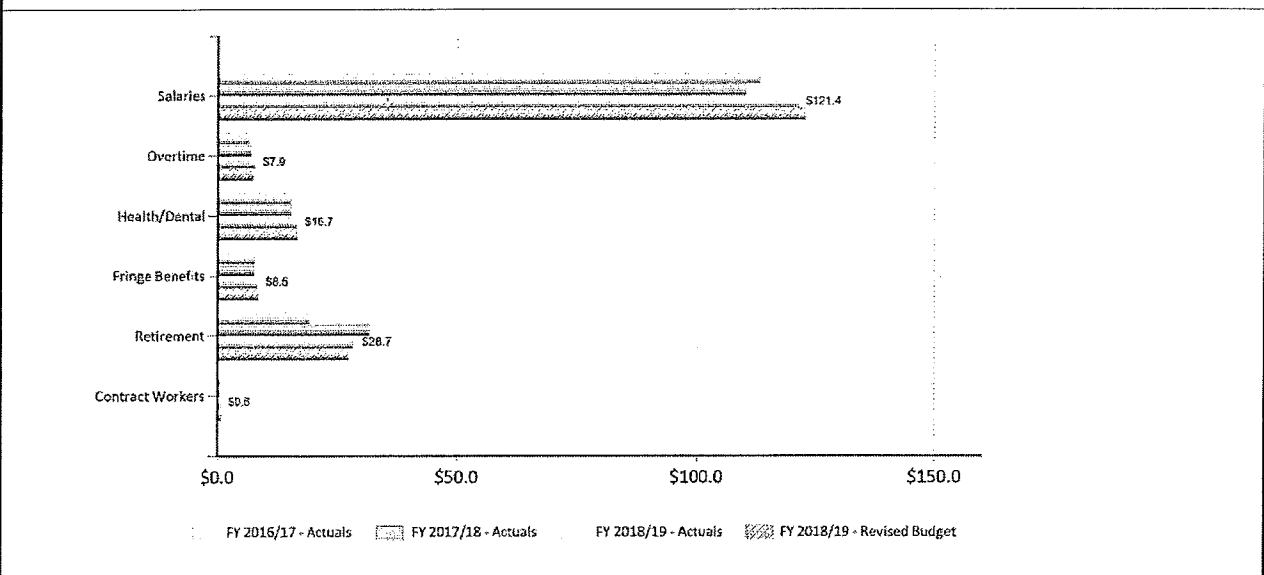

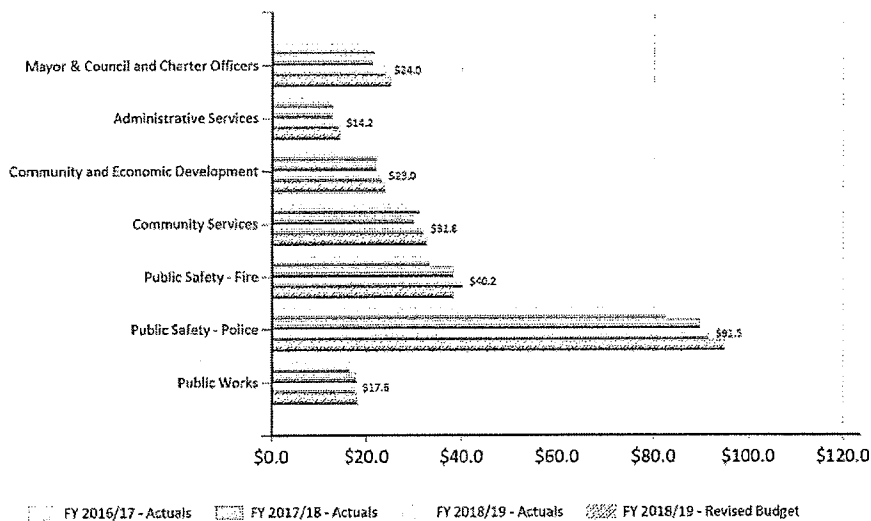
