## **PUBLIC COMMENT**

Mayor Lane: Next order of business is our Public Comment period and resurfaces comments regarding non-agendized items which no official Council item will be taken at this time. On these items. Comments are limited to issues within the jurisdiction of the city Council and speakers are limited to three minutes and they are individually allocated three minutes, there's no combining and there will be another opportunity at the end of the meeting if in fact it's needed. For that Public Comment. We'll start with Stuart Graff.

Stuart Graff: Mayor, Vice Mayor, members of the Council, thank you for this opportunity. I am the president and CEO Stuart Graff at Taliesin West, the Frank Lloyd Wright Foundation up in northeast Scottsdale, I think you all know it well. I want to share with you some of what we're doing there and then talk to you about the impact that Experience Scottsdale has on our work. We are the host to more than 110,000 visitors a year and recent survey data shows more than 80% of those folks come from outside of Maricopa county and more than 80% come to us for the first time when they visit us. That means our public outreach efforts are very, very critical to us in attracting new visitors and securing the tens of millions of dollars of economic impact that we have on the Scottsdale

community.

The work we do with Experience Scottsdale takes several forms. They are general outreach programs almost always includes Taliesin west as an opportunity for visitors coming here to experience a bit of Arizona and Scottsdale history as well as legacy of art and culture, that has been so important in our community and indeed in our nation. Beyond the general outreach which is bringing media writers, travel writers up to us many times through the year, they also have helped us with social media, video they created about Scottsdale and our role in Scottsdale that was just created last month already gained more than 25,000 views and favorable comments through social media, YouTube and other channels.

Other things they're doing worthy of mention, most notably how the work they do with Scottsdale contemporary month, creating new events that take our canal convergence event and expand to a city-wide event so partnerships that we have not only with Experience Scottsdale but also with Scottsdale Arts and with local hospitality community make a possible for us to present our community in a different way to visitors from outside. Therefore I would like to encourage you to continue your support for Experience Scottsdale and I hope that you will do so. Thank you very much.

David Ortega: Thank you Mayor and Council for your service. You received correspondence regarding case DR 58, regarding a mural in Scottsdale. At that time of record the applicant was admonished not to trespass on the property and on December 27th people did trespass on the property in violation of discussion of DR. And as this perhaps is readable you will see that the likely suspects are Mr. Eric Marvan, Chan Sucart and Bass. So how do we know this? They took a selfie. This is their own picture of their own violation of that date.

So my first question will be to Mr. Washburn in the legal department, that is, have they had an opportunity to cite, to summons to court the alleged perpetrators who did trespass on the property? I was called on the next day when he said gee, this is right in the face of my tenants and there's paint on the parking lot. He immediately hired a security company, that security company showed up in the afternoon of the 28th and sure enough on the evening the same people showed up with paint cans spraying and trespass the property this time on foot. This was totally not what was expressed and both by the staff which admonished them not to do that. The results were what Mr. Schade's customers got to see, that is people parking on his property. You can see various bloody noses, you can see shirts that have running from them, this is the kind of thing people pay big money to park in Scottsdale on Mr. Schade's properties have to endure.

Along the way, the security company called the police. And Scottsdale PD showed up, by the way, not only did they paint the wall, they also sprayed Mr. Schade's property. You will see two or three blue bulls, we usually call this vandalism and all this has been sent to you by email but I can't provide this in as well. Finally, the people went ahead and obstructed police officers that were called, a police officer that was called to remove them from the site. They held them off approximately three hours while they continued to tag their building and stain his property and so forth.

So my question to Mr. Washburn's office, will he then take action which includes a citing, summons for these three parties? Because Scottsdale code does require that, that is that when there is an infraction and in fact one of the greatest infractions with the \$2,500 penalty is violating DR board. The second most is.......

Mayor Lane: We have a Mayor and Council item and this is for the ordinance regulating the use of handheld communication devices while driving. This is at the request of Councilman Klapp to direct City Manager to agendize a possible action on ordinance to regulate the use of handheld communication devices by all drivers driving in city of Scottsdale. The only action to be taken on the item is to whether to agendize the matter at future Council date so no Public Comment is taken at this time on the issue. It is therefore in front of us. If Councilwoman Klapp would like to make any further comment on that, otherwise we'll move to a motion.

Councilwoman Klapp: I'll briefly comment. I know we're not having discussion but I have been asked by a number of parties why this is coming forward. And I would have to admit that it was somewhat prompted by the horrific accident that occurred with the officer from the Salt River Pima Maricopa Indian community not long ago. It is been my belief for a long time that regulating distracted driving, particularly the use of handheld devices in cars, is a real public safety issue. We have had this issue addressed by our neighbors, ironically the Salt River Pima Maricopa Indian community has a regulation against texting while on their land. Phoenix has a texting ordinance. Tempe has an ordinance that controls use of handheld devices. A number of other cities in the valley have dealt with this issue with ordinances as well. So I want to say that because of that, I would like to have a discussion here in the city of Scottsdale as well. I think the time is probably right for that discussion. So I would make a motion to direct the City Manager to agendize presentation discussion and possible action on an ordinance to regulate the use of handheld communication devices by all drivers driving in city of Scottsdale.

Mayor Lane: Motion made by Councilwoman Klapp.

Vice Mayor Phillips: Second.

Mayor Lane: Seconded by Councilman Phillips. Councilwoman Milhaven.

Councilwoman Milhaven: I want to comment on whether to discuss or not to discuss. Representative Kavanaugh is introducing a bill at the state level, while I'm in support of having discussion, a statewide solution is preferable so I'm not supporting the motion. Thank you.

Mayor Lane: Any further comments? I would just say that I, in a similar situation I believe a statewide effort is an important one, but since generally we're just talking about advancing the conversation, that's a very same thing that might be discussed in that position. It should be at that point in time. So I'm going to support the conversation with hopes we'll move in that direction. That's the most I can say without getting further debate on the subject at this point in time. I must, so to completely understand our process is that anything that we agendize we have to vote to put on the agenda but in the process not to start discussion on it. That's what we guard ourselves against a little bit. So we're careful, we have covered that base. Any case, motion is on the table and motion is made and seconded. So I think we're ready to vote. All in favor indicate by aye. It does succeed with Councilwoman Milhaven opposing this particular motion. So we have completed our work for this evening.
