Barrett Jackson Fall Auction Event Funding

City Council Meeting – September 22, 2020

Barrett Jackson Fall Auction

- The three-day October auction event will be held at WestWorld in Scottsdale and will feature approximately 500 collector vehicles for auction. The event is car auction centric with limited ancillary activations, different targeted attendee demographics, and marketing strategy from the annual January auction event.
- On August 18, The Tourism Development Commission determined that the Barrett Jackson October auction event was separate from the January auction event and unanimously recommended that City Council support the one-year event funding agreement.

Analysis & Assessment

- The auction event will have extensive media exposure with 21 hours of television coverage and estimated attendance of more than 5,000 on-site. Contracted room rates are in place at multiple Scottsdale hotel properties.
- The event will include a hybrid of onsite, online, and linear broadcast elements. Estimated direct advertising expenditure is expected to be \$200,000.
- The marketing and promotional benefits outlined in the proposed agreement provide direct consideration substantially equal to the city's expenditure.







Goal/Purpose of Request:

The applicant's request is to rezone the +/- 17.52-acre site to allow for the configuration of a 14-lot single-family residential subdivision.







- Letters received sighting concerns over individual maintenance/liability of the on-lot Scenic Corridor and Trail alignments and that the associated subdivision design is not providing open corridors between each individual lot as other developments have done.
