Appointment: Joseph Shershenovich was appointed to the Tourism Development Commission, effective June 24, 2025.

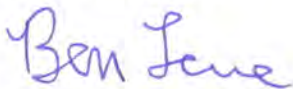
MOTION AND VOTE – ADJOURNMENT
