PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was led by Councilwoman Janik.

MAYOR'S REPORT

Mayor Ortega called attention to the ongoing wars in foreign countries as they fight to protect their democracy and freedom and asked for a moment of silent reflection for these war-torn countries and for the safety of our military personnel.

Mayor Ortega presented a Citation of Merit for all city personnel for their work during Scottsdale's high season of activities and events, which starts in November and continues into May.

Mayor Ortega presented a proclamation declaring Inflammatory Bowel Disease (IBD) Awareness Week in Scottsdale. The proclamation was presented to Scottsdale residents.

Mayor Ortega noted that it was graduation week, noting it was a great time to celebrate and bring a close to Scottsdale's event season.

Mayor Ortega thanked Vice Mayor Whitehead for her service as Vice Mayor and announced Councilmember Graham would be the next Vice Mayor starting in June.

7. Scottsdale Community Sustainability Plan

Sustainability Director Lisa McNeilly gave a PowerPoint presentation (attached) on the proposed Scottsdale Community Sustainability Plan.

Mayor Ortega opened public comment on this item.

Jim Davis, with the Coalition of Greater Scottsdale, requested fiscal sustainability be added to the Sustainability Plan and noted that Scottsdale is underinvesting in its assets' maintenance.

Austin Fairbanks, Scottsdale resident, stated the Sustainability Plan would have no major impact on the environment at large, yet would be costly to implement.

Patricia Badenoch spoke in opposition to the Sustainability Plan and noted concerns about the wording in the Plan.

Paul Rowe spoke in opposition to the Sustainability Plan and its potential impacts to quality of life.

Robbie Louchheim spoke in opposition to the Sustainability Plan.

Jim Haxby spoke in opposition to the Sustainability Plan due to increased costs to residents without a clear benefit.

Bob Pejman spoke in opposition to the Sustainability Plan, noting the Plan did not address overdevelopment.

Geoff Kull spoke in opposition to the Sustainability Plan due to potential rate increases and restrictions on individuals.

Mayor Ortega closed public comment and noted there were a number of written comments submitted on this item.

MOTION AND VOTE – ITEM 7

Councilmember Durham made a motion to continue the possible adoption of Resolution No. 13107 to a later date to allow additional community outreach with at least two community outreach meetings being scheduled by city staff. Councilwoman Janik seconded the motion, which carried 7/0, with Mayor Ortega; Vice Mayor Whitehead; and Councilmembers Caputi, Durham, Graham, Janik, and Littlefield voting in the affirmative.



Reasons for this Development Agreement

- Allows for the construction of a sewer servicing the area north of the CAP canal and south of the 101 between Pima Road and Scottsdale Road with an accelerated schedule, minimizing community impacts and opening this area for current and future development
- Funding:
 - Optima funds construction with reimbursement from the city for capacity that is not required for Optima.
 - Sewer Development Fee Funds are used for those portions of the IIP that are constructed.
 - Attaches payback requirements on future development in the area to ensure future growth pays for the oversizing of this line.

Proposed Amendment

- Increase the amounts allowed for reimbursement to account for escalating costs.
- Divides the portion of the sewer line in Exhibit A-4 into 6 additional segments allowing for faster segment completion.
- Funding:
 - Percentage of funding responsibilities do not change
 - Budget increase of \$19,000,000 requested

Reasons for Budget Increase


- GMP 3 for Optima was presented to the city in mid-March with a not to exceed cost of \$27,434,370.22 after the February 20th budget request presented to Council on the TPC Sewer segment.
- The original project (IIP-05) cost was developed using 2019 cost (prepandemic) pricing
- The original project called for upsizing two existing 18-inch diameter sewers to 21 and 30 inch diameter segments. The current project calls for a new 27 to 36-inch parallel pipe.

7

Reasons for Budget Increase

- Changes is pipeline alignment due to the increased size of the pipeline and the desire to minimize construction disruption to the local community and the TPC Stadium Course.
- Changes in pipe and manhole materials to increase the life of the sewer line and reduce maintenance cost.
- Uncertainty of alignment in Bureau of Reclamation (BOR) lands as well as jack and bore requirements under the BOR flood levee.
- Complexity with on-going 101 construction







ACTIONS

- HT 4.2 Encourage use of desert-adapted trees to support heat reduction and water conservation strategies.
- HT 4.3 Investigate an urban forestry program to balance shade and water use and to ensure trees are maintained (including in city parks).


