CALL TO ORDER

Mayor David D. Ortega called to order a Special Meeting of the Scottsdale City Council at 6:05 P.M. on Tuesday, June 4, 2024 in the City Hall Kiva Forum.

1. Final Adoption of Fiscal Year (FY) 2024/25 Budget Estimates and Five-Year Capital Improvement Plan

Requests:

1. Adopt **Ordinance No. 4642** setting the final budget estimates for the FY 2024/25 Budget as tentatively approved on May 14, 2024; adopting the final FY 2024/25 Job Classification Plan and Job Classification Pay Table in conformity with Scottsdale Revised Code Sections 14-20 through 14-24; and authorizing or approving, as applicable, certain salary adjustments included in the Final Budget for City employees and Charter Officers and setting the salaries of the Presiding Judge and Associate Judges.
2. Adopt **Ordinance No. 4643** approving the Capital Improvement Plan for the period beginning July 1, 2024 and ending June 30, 2029.

City Treasurer Sonia Andrews gave a PowerPoint presentation (attached) on the proposed final adoption of the Fiscal Year 2024/25 Budget Estimates and Five-Year Capital Improvement Plan.

2. Adopt Ordinance No. 4643 approving the Capital Improvement Plan for the period beginning July 1, 2024 and ending June 30, 2029.

Councilwoman Whitehead seconded the motion, which carried 6/1, with Mayor Ortega and Councilmembers Caputi, Durham, Janik, Littlefield, and Whitehead voting in the affirmative and Vice Mayor Graham dissenting.

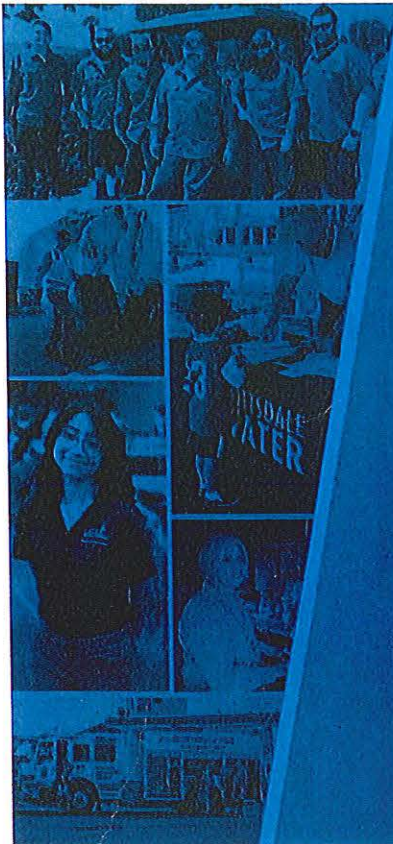
