CALL TO ORDER

Mayor Lisa Borowsky called to order a Special Meeting of the Scottsdale City Council at 4:02 P.M. on Tuesday, March 24, 2026 in the City Hall Kiva Forum.

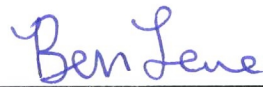
